

LIAC has tremendous potential to expand the business of the law, locally and internationally, by facilitating faster resolution of commercial disputes through arbitration and other alternative dispute resolution mechanisms.

There is still more to be done! The reformation of our regulatory space to re-position the legal profession to better meet the demands of the 21st Century is already underway.

On behalf of the entire Council and indeed on my on behalf, allow me to express my gratitude to all the members of the Association, severally and jointly, for the unwavering support you continue to render to my team. There is no LAZ without you all. 

## PRESIDENT'S REMARKS





## THE ZMW50,000.00 FUNERAL POLICY

Lawyers boast of belonging to the most noble profession and live lives that are of very high standards. However, some deaths of our learned colleagues that have gone before us have shown that there is a real need to prepare for such eventualities.

In a bid to offer the members a dignified send-off and in looking out for Members' welfare, Your Council took out a Life Assurance Policy (the Policy) with ZISC Life that guarantees payment of ZMW50,000.00 in the event of a member's death. In the past, the Association made a contribution of ZMW3,500.00 towards a member's funeral. We could not continue this trend.

The Policy was taken out having understood that the Association's funds are inadequate to pay out a huge sum in the event of each death. We are happy to report that every deceased member's family that has passed away from October 2022 is fully covered under the Policy.

To ensure the sustainability of the Policy, your Council took out a 15-year Government Bond at ZMW2,300,000.00) whose annual coupon is in excess of ZMW500,000.00.

The Annual General Meeting approved the transfer of the Government Bond to the newly created Lawyers Cooperative, which would now be responsible for the payout of Association Contributions in the event of a Member's death.

Once the Current policy comes to an end in October 2023, the Lawyers Cooperative will manage and run the Funeral payout to members' families through the guaranteed returns from the Government Bond. We have fixed this problem for good!


CONTINUOUS PROFESSIONAL DEVELOPMENT AND THE DIGITISATION OF LAZ

The Law Association of Zambia Act, Chapter 31 of the Laws of Zambia section 4(d) enjoins the Association "to promote the education of lawyers at all stages and levels, with particular emphasis on the broadening of such education."

As a way to carry out this mandate, the Council launched the E-LAZ Continuous Professional Development (CPD) Portal in conjunction with MOTI a company from Cyprus. This portal enables members to engage with an ever-growing library of short courses, one to three hours in duration which a member can complete at their own pace. Some of the courses in the launch special were Networking for Lawyers, Managing a Team in a Law Firm, Drafting and Advising Clients on Share Purchase Agreements, and Judicial Precedent and Statutory Interpretation. Members will also note that all the webinars that have taken place each year will similarly be uploaded onto the portal to allow users to revisit the content at their convenience.

In a further quest to digitise its operations, go paperless and save members time, your Council has also been working on e-licensing which enables all members irrespective of the location to apply for and receive their practicing certificates from the comfort of their offices. E-licensing is at test phase and will be launched in the 2024 licensing cycle!





### LAWYERS COOPERATIVE

Section 4 of the Law Assciation of Zambia Act, Chapter 31 of the Laws of Zambia does, among other things, mandate the Law Association of Zambia (LAZ) with the promotion of the welfare of its members. The increased lawyer population and changing business dynamics mean that LAZ ought to find innovative ways of promoting the welfare of its members especially where business sustainability is concerned. This led the LAZ Council to incorporate a special purpose vehicle, Lawyers Multi-Purpose Cooperative Society Limited (the Lawyers Cooperative), specifically designed to provide for the financial welfare of its members. The formation of the Lawyers Cooperative was approved by the Annual General Meeting (AGM).

The Lawyers Cooperative has been incorporated under the Cooperatives Societies Act, of 1998 and membership is open to all LAZ members.

The design of the Cooperative as a welfare vehicle is to provide financial, social, and professional support to LAZ members through collective savings and investments.

With respect to eligibility, it is worth noting that every fully paid-up member of LAZ is by default a member of the Cooperative. A fully paid-up member of LAZ is subscribed to the Cooperation to the tune of 1000 shares, which in turn has been invested in bonds. Each subscribed member is then encouraged to invest more shares within the rules set by the Cooperative's Board of Directors.

The Cooperative will be under the management of a Board of Directors answerable to the Council and will be responsible for managing the funeral policy now raised to ZMW50,000.00, promoting savings of members and make collective investments to generate economic returns for members to ameliorate hardships, especially in retirement age and other times of need.

In the interim, risk-free investments such as government bonds will be prioritised.

As the Cooperative grows its financial muscle and is subject to stringent investment guidelines, it will open up lending to members to address the challenge of lack of access to affordable finance. Council is alive to the challenge of access to finance which has seen some start-up Law firms folding and, in many instances, unable to grow past their formative stages. In other instances, members are unable to form firms due to a lack of start-up capital.

Your Council has taken its mandate of promoting the welfare of its members seriously, especially given the weight of responsibilities that members execute to the public. As a fully operationalized vehicle, the Lawyers Cooperative is a game changer in savings mobilization and collective investments to generate meaningful returns which can be drawn in times of need by the membership.

To ensure that the affairs of the Cooperative are in capable hands, the appointed Board members have a proven professional track record in managing critical institutions in the country. The Board Chairperson is Dr. Tukiya Kankasa Mabula, former Deputy Governor of the Bank of Zambia, the Treasurer is Mrs. Lydia Sameta Chilumba, former Corporation Secretary and Head of Legal at National Pension Scheme Authority (NAPSA) while the Secretary is Ms Miria Mazyambe, Acting Chief Executive Officer and Company Secretary of the Lusaka Securities Exchange Plc (LuSE). Dr Alex Chola Kafwabulula, former Executive Director of the Food Reserve Agency (FRA), and Mrs Liya Banda Tembo, the Acting Director General of the Financial Intelligence Centre (FIC) are the other Board members.

The Board has kickstarted the process of operationalisation of the Cooperative; and will shortly announce the commencement of the collection of savings from members through the purchase of shares. Let us all invest collectively, for a secured legal, and financial future!

# 50 NOBLE CAUSES – A SPECIAL PRO BONO SESSION OF THE HIGH COURT AND COURT OF APPEAL

Like many English legal terms that borrow their roots from Latin maxims, the phrase "pro bono" is derived from the Latin phrase pro bono publico, which refers to work, or actions carried out "for the public good".

Since 1973, the members of the Law Association of Zambia (LAZ) have provided free legal services to the marginalised of a quality equal to that afforded to paying clients within the existing legal framework. In May 2022, the Annual General Meeting (AGM) resolved to adopt the Pro Bono Policy which would act as a framework for the provision of pro bono services by legal practitioners. This is in addition to the Association's flagship pro bono program, the Legal Aid Clinic for Women, which provides legal aid to the most indigent among us, women and children.

This year, as part of the Golden Jubilee Celebrations for LAZ, Members of the legal profession gave back to society by taking on fifty (50) criminal cases, pro bono, in a special session of the High Court and Court of Appeal, in the Lusaka and Copperbelt Provinces. The 50 cases were broadly in three categories, namely; murder, aggravated robbery, and causing death by dangerous driving.

The Chief Justice descended to sit as High Court Judge for purposes of formally opening the session on 20 March 2023, a very rare occasion. Sincere gratitude is extended to the entire bench for supporting the bar in this important access to justice initiative.

After the Special Session, LAZ President in his graceful style individually sent a 'Thank You Letter' to LAZ Members who volunteered their time. The letter in part read:

"Your monumental effort made a remarkable difference to the success of the noble cause, which is, according to me, one of our most significant accomplishments ever."

Indeed, the Special Pro Bono Session was a significant accomplishment for both the bar and the bench. Looking forward to many more to come with increased participation from the Members. Forward and upward, we must continue with such noble causes, 'vers l'avant et vers le haut', the French would say.

With the rate of unemployment among legal practitioners rising to nearly unprecedented levels, the challenge of low wages, especially among Junior Lawyers, has become even more pervasive. The Law Association of Zambia (LAZ), being alive to this growing challenge – if not an affront to the dignity of the legal profession – has previously taken decisive steps aimed at ensuring enhanced conditions among junior lawyers, more particularly in terms of employment creation and payment of decent wages.

With that priority in mind, the LAZ Council commissioned the Jesuit Centre for Theological Reflection (JCTR) to undertake research in support of the LAZ agenda to implement the LAZ Standard Wage. At the end of the research, which culminated in the report that was thoroughly considered and discussed by the LAZ Council. The LAZ Standard Wage for Junior Lawyers was then set at ZMW12,000.00 net, as recommended by JCTR.

The LAZ Standard Wage is a tool that will protect junior lawyers from exploitation within their respective workspaces.

In addition to the Standard Wage of ZMW12,000.00, JCTR further recommends that:

- a. (LAZ revisit regulations requiring junior lawyers to work for at least five (5) years before being eligible to open their own law firms;
- Law firms evolve and diversify, to keep abreast with the changing times and, thereby, remain relevant, with the hope that such diversification will enhance revenue collection and thereby attenuate the challenges of unemployment among the junior lawyers; and
- LAZ consider reducing the practising certificate and license fees, including the fees attendant to the Annual General Meeting (AGM) for junior lawyers.

To date, the LAZ Council has continued to intensify its engagement with various employers as stakeholders — including the government of the Republic of Zambia (GRZ) and law firms — with the view to enhancing employment opportunities for Junior lawyers, as well as emphasising the application of the LAZ Standard Wage of ZMW12,000.00.

Additionally, the LAZ Council, working in liaison with the executive committee of the Junior Lawyers' Committee (JLC), has continued to devise and work on practical strategies and mechanisms aimed at ensuring full implementation of the Standard Wage, against the backdrop of the recommendations reported by JCTR.

The LAZ Council continues to place unwavering primacy on the plight of its membership, particularly the junior lawyers, while also ensuring, as far as possible, that the growing challenges of unemployment on the one hand, and meagre payment of wages on the other, are addressed to the latter.

Furthermore, LAZ has continued to initiate interventions aimed at expanding the business of the law as a way of addressing the financial capacity of employing law firms. Follow-up engagements and monitoring activities will be implemented to ensure full implementation of the LAZ Standard Wage of ZMW12,000.00

## LEGISLATIVE REFORMS: THE DRAFT LEGAL PROFESSION BILL AND LEGAL PRACTITIONERS PRACTICE RULES

In April 2023, the general membership at the Annual General Meeting (AGM) resolved to review and reform the legislation that governs the Legal Profession in Zambia to reposition it to support the needs of the 21st Century; and that subject to members' further input to the draft Legal Profession Bill and draft Legal Practitioners Practice Rules and subsequent Stakeholders comments thereon, the same be finalised for onward submission to the Ministry of Justice for further legislative processes.

Following the AGM, Council embarked on the legislative journey of repealing and replacing the Legal Practitioners Act Cap 30 of the Laws of Zambia and the Law Association of Zambia Act Cap 31 of the Laws of Zambia.

The exercise, which is being driven by the Law Reform, Development and Research Committee, will result in the merging of the two pieces of legislation into one Statute, to be called the Legal Profession Act. The Bill seeks to, among other matters, modernize law practice; continue the existence of the Law Association of Zambia and re-define its functions; provide for the forms of legal practice and Limited Liability Partnerships (LLPs); define professional misconduct and provide for disciplinary procedures for the legal profession; provide for striking off and restoration to the Roll of practitioners; and provide for professional liability indemnity and client compensation.

The Bill incorporates contemporary issues such as the following:

- Representation of both junior lawyers and senior lawyers on the Council;
- Enhancement of Corporate governance in law firms. The council will be responsible for executive functions while the Executive Director with Secretariat will be responsible for the day-to-day management of the Association;
- Provision for the admission of articled clerks to be repealed (with a saving provision for those who are already practitioners):
- Legalising the charging of contingency fees by practitioners;
- Practitioners have an option of setting up Limited Liability Partnerships or partnerships under the Registration of Business Names Act;
- Statutory protection of a Legal Practitioner's legal fees and costs;
- Anti-Money Laundering and Regulatory compliance matters;
- Protection of the legal profession space against quacks/unqualified persons;
- Reform in the election, composition, qualification, procedure, and powers of the Legal Practitioners' Committee and the Disciplinary Committee; and
- Liability insurance by Practitioners against future claims by clients for misconduct.

Simultaneously with the Bill, Council has also been reviewing the Legal Practitioners Practice Rules to harmonise them with the Bill as well as matters affecting modern practice such as current trends in law firm management.

LAZ held a four (4) day engagement meeting, on the 15th,16th,28th, and 29th of June 2023, with LAZ members of various stature at the Bar with a view of getting their views on the topical issues in the Bill and the Rules. Following the conclusion of this process, Council will, in the next three months, engage external stakeholders such as Patents and Companies Registration Agency (PACRA), the Ministry of Justice, and the Judiciary for their buy-in. The Bill will thereafter be formally submitted to the Ministry of Justice for Cabinet approval in principle and enactment.



### THE LUSAKA INTERNATIONAL ARBITRATION CENTER-LIAC

Considering the challenge of delayed commercial disputes in Zambia and the absence of a robust institutional framework to support institutional arbitrations and other alternative dispute resolution mechanisms (ADR), it became critical to look at the formation of an institution to administer arbitrations and ADR in the country.

The Council resolved to establish the Lusaka International Arbitration Center (LIAC) in conjunction with the business community, as a private sector initiative, in response to the increased demands by the business community for predictable and faster resolution of commercial disputes in the country.

The Law Association of Zambia (LAZ) and the Chartered Institute of Arbitrators – Zambia Branch, an arbitral institution and branch of the Chartered Institute of Arbitrators, United Kingdom (CIArb Zambia) in January of 2023 signed a memorandum of understanding to collaborate with the local and international business community and other stakeholders to establish an international arbitration center in Zambia called the Lusaka International Arbitration Center (LIAC).

Engagements were then made which culminated into the signing of a memorandum of agreement for the formation of LIAC. The legal profession, the Chartered Institute of Arbitrators Zambia Chapter, the private sector representative organizations which included the Zambia Chamber of Commerce and Industry (ZACCI), the Zambia Institute of Chartered Accountants (ZICA), the Engineering Institution of Zambia(EIZ), Association of Consulting Engineers of Zambia (ACEZ), Zambia Chamber ofMines (ZCM), Zambia Institute of Architects (ZIA), the French Business Forum, the Italian Business Club, Zambia Association of Manufacturers (ZAM), the Bankers Association of Zambia (BAZ) formally backed the formation of LIAC as guarantors.

LIAC has since been incorporated as a company limited by guarantee effective 12th June of 2023 with a Board of Directors comprising of highly experienced and qualified Directors the guaranteeing institutions led by the President of the Zambia Chamber of Commerce and Industry, Dr Chabuka Kawesha as Board Chairperson. Suzanne Rattray and the LAZ President Lungisani Zulu are co-Vice Board Chairpersons, James Banda, President of the Chartered Institute of Arbitrators Zambia Chapter, Cecilia Zimba, President of the Zambia Institute of Chartered Accountants and Mizinga Melu, President of the Bankers Association of Zambia are Directors. Abel Ng'andu President of Engineering Institution of Zambia, Misheck Daka President of the Association of Consulting Engineers of Zambia and Sokwani William Chilembo, the Chief Executive Officer of the Zambia Chamber of Mines are the other Directors. KPMG Zambia, the World-renowned accounting and auditing firm is the Company Secretary of LIAC.

The incorporation of LIAC was momentous for LAZ as it provides a preferred international platform for speedy disposal of commercial disputes in the country. The Centre is positioned as a sustainable solution to the delayed resolution of commercial disputes. It will consequently decongest the Courts of law and enhance access to justice by redirecting commercial disputes away from the Courts and create time and space for matters not suitable for resolution via alternative dispute resolution. LIAC has boosted investor confidence for business and investment

in the country as it assures the business community of speedy resolution of commercial disputes thus spurring commerce.

LIAC is open to individuals and commercial entities that desire to have their disputes resolved by way of mediation, arbitration, and other forms of alternative dispute resolution. The Center will also offer conciliation services and conferencing facilities for arbitration and meetings. It is a safe place to arbitrate and a suitable venue for holding hearings.

The Board has since commenced the operationalization of LIAC by developing the internal rules for conducting arbitration, mediation and adjudications under LIAC as well as the LIAC Standard Clauses which lawyers and their clients shall incorporate into their commercial agreements in order to opt to refer all disputes relating to their agreements to be finally resolved by arbitration administered by the Lusaka International Arbitration Center (LIAC) as per the LIAC Arbitration Rules.

The Chinese Business Community has since signed a memorandum of understanding with LIAC to facilitate the resolution of dispute resolution affecting Chinese Investments in Zambia at LIAC. LAZ is encouraging the membership, business community, government and the general public to take advantage of this facility and utilize the services offered by LIAC.

The Pan African Lawyers Union (PALU) is the premier continental membership forum for individual African lawyers and lawyers' associations in Africa. # GETTING RID OF MASQUERADERS AND QUACKS: THE REGULATORY ENFORCEMENT COMMITTEE OF THE LAW ASSOCIATION OF ZAMBIA

The Regulatory Enforcement Committee (the Committee) was set up by the Council of the Law Association of Zambia (LAZ) to fight the increased incidents of unqualified persons offering legal services in breach of the law. These legal services without limiting the generality of the foregoing include debt recovery, land transfers and other conveyancing matters or litigation services.

The Committee was also set up to provide public awareness on the dangers of providing a legal service without a license in breach of the provisions of the Legal Practitioners Act Chapter 30 of the Laws of Zambia; and other offenses connected to the same such as aiding and abetting.

The Committee is guided by nine (9) Terms of Reference. Broadly speaking, these include tracking; investigating and prosecuting; subject to the requisite fiat; violations of the Legal Practitioners; Act as well as all related legislation such as the Lands and Deeds Registry Act, Cap 185 of the Laws of Zambia; in addition to advising Council on any remedial measures.

The Committee is comprised of twelve (12) Members namely; Mr. Wezi Mwandila, Mr. Mwandu Nsama, Mrs. Gorretti Sakala Ngoma, Ms. Lilian Nankamba, Mr. Probby Shambulo, Mrs. Sandra Jacobs Harawa, Mr. Nkwachi Kanyimbo, Ms. Kambole Chisanga Seta, Ms. Sophie Munkombwe and the now late Ms. Royce Mudenda. Three (3) Council Members namely; Mrs. Womba Silumbu Kankondo, Mr. Brian Mbilima and Mr. Arnold Kaluba oversee its operations.

The Committee's first inaugural meeting was held on 5th June 2023 and is scheduled to meet once every month. In a bid to raise public awareness on the practice of the Law by unqualified persons and its dangers, the President of LAZ had his 1st appearance on ZNBC TV 2 on 21 July 2023 while the Committee has issued several writeups on the same.

In addition to getting rid of quacks, the Committee is increasingly finding infringemnts of the legal space by accounting and audit firms as well as estate agents. Also unfortunate and worrisome is the recent trends of legal practitioners incorporating companies offering legal services as consulting firms, something outlawed under the provisions of the Legal Pracitioners Act.

All complaints are to be channelled to a dedicated email address; complaintsrec@laz.org.zm for the Committee's attention. Thereafter, the Committee gets fast at work to act on the complaints received.

The work of the committee is on the backdrop of an unlicensed person, Abel Musonda Muyembe, being convicted for practicing law without a license and sentenced to 1-year imprisonment.

With the Committee in place, the Legal Profession is expected to reclaim its space in all areas of the practice of the law.

### GREENING THE LEGAL PROFESSION: THE TASK FORCE ON CLIMATE CHANGE

The Law Association of Zambia Council (the Council) resolved to establish a Special Task Force on Climate Change (the Task Force) to spearhead the legal profession's response to climate change and sustainability as well as support the Government's green initiatives.

This establishment of the Task Force on Climate Change is in recognition of the essential role of the legal profession in addressing climate change.

The Task Force is mandated broadly to raise awareness and facilitate capacity building of the LAZ membership on climate change issues. The capacity building is aimed at closing the existing gap in the climate capabilities of lawyers; and enabling them effectively engage with and participate in the climate change domain as well as contribute to current and future legislative and regulatory policy making and reform. Indeed, the Law Association of Zambia (LAZ) recognises the opportunities that climate change presents as a growth area for law practice.

This is a deliberate effort to build the capacity of lawyers to effectively contribute to the climate change agenda and sustainability having recognised the urgency and threats climate change poses on the country. The Task Force is a mechanism to empower lawyers on climate-change-related legal issues, so as to assist the business community and Government to accelerate the transition to a green economy.

The Task Force whose membership is drawn from LAZ members in the private and public sector is headed by Dr. Lanette Kambole Chiti, with PhD in International energy law and climate change. Susan Clayton, Florence Chibwesha, Nkhonde Nyakhata Fumbeshi, Natasha Banda-Museba, Joseph Syanyabo, Mehluli Batakathi Malisa, Kalonga Numero Saka, Menya Masabo and Larry Njungu complete the full list of the Committee.

In accordance with its mandate and in response to the above-stated needs, the Task Force has commenced its work and has since developed a climate change capacity-building programme for the LAZ membership. The primary objectives of the climate change capacity building program are to:

- i. Enhance the knowledge of lawyers on the science of climate change, national and international climate change legal frameworks, climate change adaptation and mitigation strategies, current and emerging mechanisms provided by the international climate change regime and relevant treaty bodies, legal aspects and implications of climate change on the practice of law.
- ii. Strengthen skills among lawyers for the analysis, interpretation and effective application of climate change-related laws and policies, develop skills for undertaking negotiations including multilateral climate negotiations, advocacy, climate litigation and for legal drafting pertaining to climate change issues and transactions.
- iii. Enable lawyers to contribute to climate law development or reform, and implementation of climate change policies that are coherent, legally robust and in alignment with national and international objectives.
- iv. Facilitate networking and collaboration among lawyers working in the field of climate change within Zambia and at regional and international levels and encourage the sharing of experiences, best practices, and resources to maximize collective effort.

The Task Force will commence fundraising efforts to support the rolling out of its capacity-building programme.

The Task Force also complements the work of LAZ at regional level, through the Southern African Development Community Lawyers Association (SADCLA), where LAZ through the Presidency leads the SADCLA Committee on Climate Change and Sustainability. Members are urged to take a keen interest in contributing to creating a climate change-conscious practice and take advantage of new business opportunities in this space. Let us all use the instrument of the law to further the growth of society in the climate change agenda.

Ultimately, the consultant will be expected to produce a draft Strategic Plan, Review Report, along with a proposed Strategic Plan for the period 2025 to 2029. Members are expected to input into this important process.

### II. ORGANISATIONAL POLICIES

To enhance organisational efficiency, equity and fairness and in line with good corporate governance practices, Council resolved to develop organisational policies for the Association. A consultant was engaged to spearhead the process. The policies sought to be developed are procurement policy; human resource policy; including such sub-policies as the Sexual Harassment; HIV/AIDS Workplace and Wellness policies; transport policy; and finance policy. It was noted that the Association already had in place a transport and sexual harassment policy. As such the consultant was expected to incorporate the same into the policies to be developed.



This was in furtherance of LAZ's duo mandate to promote the education of lawyers at all stages and levels, with particular emphasis on the broadening of such education and to co-operate with other institutions, specifically institutions of higher learning for lawyers.

Some notable institutions visited include the Copperbelt University, Northrise University, Rockview University, LUITEBM University and Eden University. Topics of discussion included the role and discipline of a lawyer in society, the importance of Mentorship and internship during university period.

Furthermore, in a bid to boost the morale and momentum of the Zambia Institute of Advanced Legal Education (ZIALE) students, LAZ visited the institution on the 15 November 2022 and had several ZIALE Student mentorship discussions on how to withstand ZIALE pressure and understanding the role of a lawyer in Society.

The Golden Jubilee celebrations also provided an opportunity for the Association to reflect on past achievements. Some notable achievements include:

- The legal profession has produced two Republican Presidents. These are; the late Dr. Levy Patrick Mwanawasa SC (MHSRIP) who was the Third Republican President and Mr. Edgar Chagwa Lungu, the Sixth Republican President.
- 2. The Alluring LAZ House situate at Plot No. 1 Lagos Road, was built from Members' contributions through the building levy.
- Establishment of the National Legal Aid Clinic for Women (NLACFW) – NLACW, established in 1990 as a project under the Women's Rights Committee (WRC) of LAZ. The project was established to provide affordable legal aid to women and children from marginalized social sectors.
- 4. Establishment of the LAZ Mentorship Programme This programme was set up in 2013 by Hon. Lady Justice Bubile Lungu Shonga and Ms. Linda Kasonde the First and only Female President of the Law Association of Zambia so far. Its purpose was 'to create a platform that nurtures and develops the talent and character of young and future lawyers.' The programme continues to run to date and is spearheaded by the Junior Lawyers Committee. So far, we have over 50 pairs.
- 5. Implementation of Policies Notable policies that have been implemented by the Law Association of Zambia Council include the Pro Bono Policy which facilitates the uptake of at least one case per for every lawyer and the Sexual Harassment Policy to create a safe space for junior and female lawyers in the legal profession.
- 6. Creation and Strengthening of Ties with Key Stakeholders Consistent with the provisions of section 4 of the Law Association of Zambia Act, Cap 31 to collaborate with various stakeholders in the execution of its mandate, LAZ has forged strong bonds with various stakeholders such as Financial Intelligence Centre; Patents and Companies Registration Agency; Immigration; Ministry of Finance; and the Ministry of Lands. The results of these collaborations include increased opportunities for appointment to critical institutions of governance in the country and expanded areas for the practice of the law for our members.

The legal profession has done quite well in the last 50 years, but as the Association's President Lungisani Zulu pledged in his speech at the official opening of the Golden Jubilee Annual Law Conference in April, 2023, graced by the Republican President Mr. Hakainde Hichilema, "society needs more, deserves more from the legal profession. We must do more, we shall do more, we are able and willing to do more for society" in the next 50 years.
